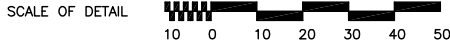
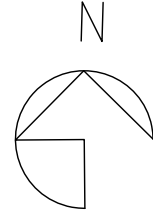

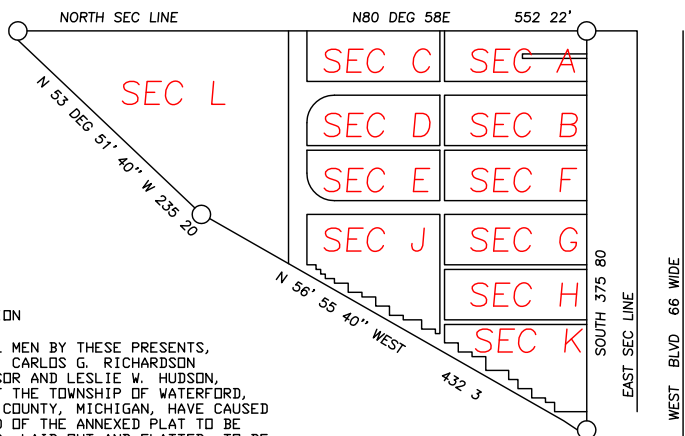

OAKLAND COUNTY, MICHIGAN IS DESCRIBED AS FOLLOWS: BEGINNING AT A POINT ON THE N SEC. LINE LOCATED S89 DEG 68' W 33 FT FROM THE NE SEC. COR THENCE SOUTH AND PARALLEL TO THE E SEC. LINE 375 84 FEET TO THE RR ROW THENCE N 56 DEG 55' 40" W ALONG SAID ROW 432.31 FEET THENCE CONTINUING ALONG SAID ROW N 53 DEG 51' 40" W 235.20 FEET TO THE N SEC. LINE, THENCE N 89 DEG 58' E 552.22 FEET TO THE POINT OF BEGINNING.
