

# **LUCA 2020 Overview**

### **Background**

In anticipation of the 2020 Census, the US Census Bureau is asking for local government participation in the Local Update of Census Addresses (https://www.census.gov/geo/partnerships/luca.html) (LUCA) Program. The purpose of this program is to improve the accuracy and completeness of the Census Bureau's address list for every municipality, to ensure that 2020 Census forms are delivered to the maximum number of households and group quarters such as nursing homes, group homes, etc.

## **Importance of Accurate Data**

Having an accurate list of addresses for the 2020 Census is critical for local entities. The population data collected during the Census contributes to the following:

- 1. Apportionment of seats in the US House of Representatives
- 2. Distribution of significant amounts of State-generated funds
- 3. Grant applications that fund community, social, economic, and environmental programs
- 4. Planning for future growth and development

## **LUCA Participation**

LUCA is a **voluntary** program in which an entity can participate by receiving and correcting either digital or paper copies of the Census Bureau's current address list for the participating entity. A **Title 13 confidentiality agreement** will be provided by the Census Bureau with the data. This agreement must be signed by anyone with access to the data and the hardware on which the data will be stored, whether the data is digital or paper. Registration for LUCA is due December 15, 2017.

## **County's CVT Coordination**

As we did for the 2010 LUCA Program, Oakland County will participate using a digital option. To prevent duplication of effort among local and county government, Oakland County will again coordinate with the local cities, villages, and townships (CVTs) in the following ways:

- 1. Send a letter to the highest elected officials at each CVT articulating the County's planned efforts regarding the LUCA Program. The work the County will be doing in support of the LUCA Program is detailed in the *LUCA Update Process* section of this document.
- 2. If necessary, schedule a meeting with CVTs to be held at the County in Fall 2017.
- 3. Track which CVTs would like to partner with the County for LUCA.
- 4. Designate a single point of contact at the County for questions (<u>luca2020@oakgov.com</u>).



#### **CVT Benefits**


LUCA is a **voluntary** program. CVTs can choose one of three options: 1) not to participate in any way, 2) participate in LUCA on their own, or 3) participate in LUCA using the process outlined above by partnering with the County. By partnering with the COUNTY, the CVTs receive the following benefits:

- 1. Oakland County will be performing preliminary work that will save the CVT time and resources in validating the final address list.
  - a) CVTs will not need to find resources to compare the Census' address list with their own, because the County will do this work for them and notify them of any discrepancies in the counts.
  - b) CVTs will not need to format their address file for submission to the Census Bureau. This is potentially a labor-intensive step that may involve GIS work.
- 2. CVTs that perform corrections to their address list in the County system (versus on a paper copy that is only submitted back to the Census Bureau), will simultaneously improve the accuracy of their master address list, which can be used for mailing, billing, or permitting purposes.

### **CVT Next Steps**

The Census Bureau will be scheduling LUCA training sessions in October, 2017 (dates to be announced by Census Bureau). Because registration is not due until **December 15, 2017**, CVTs may choose to decide if they will participate, with or without the County, after attending a Census Bureau training. However, if the CVT already knows they would like Oakland County to act on their behalf for LUCA, please do the following:

- The HEO should send an email to <a href="luca2020@oakgov.com">luca2020@oakgov.com</a> to let us know that you would like Oakland County to participate in LUCA on your behalf at your earliest convenience, but no later than November 15, 2017. Please include the name and contact information of the person in your community who will act as your LUCA contact with the County. Sending us this notification means that we will be working with your LUCA contact between February and April 2018 to validate your addresses.
- 2. The HEO at each community should have received form D-2002 from the Census Bureau. Please select the following options in the Participation section, complete the rest of the form, and return to the Census Bureau per the form's instructions:
  - Option 2: No Our government is not registering for LUCA.
  - Option 2a: Another level of government (State Or County) that includes our jurisdiction is participating in LUCA.





### **LUCA Update Process**

The County's Application Services division of the IT Department will dedicate resources to this project for the duration of the Program. At a high level, the following process will take place at the County.

CVTs who have indicated that Oakland County will be acting on their behalf are required to take the following **bolded** actions, which will take place late winter/early spring of 2018.

- 1. IT creates address reports for the CVTs using current Oakland County data.
- 2. IT compares address count by block to the US Census address count by block, highlights discrepancies, and sends reports to the CVTs.
- 3. CVTs review the address list by a specified date, making updates in either the County's (LAMS) or the local's (BSA) name and address system. We will also be seeking your feedback regarding which residential addresses are group quarters (nursing homes, groups homes, etc.).
- 4. IT creates a report of Oakland County addresses using the data corrected by the CVTs.
- 5. IT compares the resulting report to the Census Bureau's full address list.
- 6. IT requests **clarification from the CVT** if there are apparent discrepancies between the County file and the Census file.
- 7. IT creates a final address list for the Census Bureau in their required format, which may include adding additional attribution to the data.
- **8.** IT submits the final address list back to the CVTs.
- 9. CVTs sign-off on the final address list by a specified date, to be determined.
- 10. IT submits the signed-off address list to the Census Bureau.

August, 2019 thru September, 2019	The participant receives feedback on how their
	submission was processed.
September, 2019 thru December, 2019	Participants have the opportunity to appeal how the
	Census Bureau processed submissions.
