## INFORMATION SHEET FOR PETITIONS OF GUARDIAN OF INDIVIDUAL WITH ALLEGED DEVELOPMENTAL DISABILITY

Once you file a Petition, many steps must be completed before the court hearing.

This will provide general information regarding a petition that is filed and set for hearing before the court.

The Probate Court staff will assist you if you have further questions about procedures; however, staff is prohibited from offering legal advice.

### SERVICE

IT IS YOUR RESPONSIBILITY AS PETITIONER TO “SERVE” ALL INTERESTED PERSONS WITH A COPY OF THE PETITION AND NOTICE OF HEARING (STAPLED PACKETS). IF YOU DO NOT COMPLETE SERVICE, YOUR PETITION WILL BE DISMISSED, AND YOU WILL HAVE TO START THE PROCESS ALL OVER BY FILING A NEW PETITION.

#### THERE ARE 3 METHODS OF SERVICE:

<b>Personal Service</b>	Means delivering copies to the individual in person.
<b>Service by Mail</b>	Means mailing copies (only first-class mail is required).
<b>Publication</b>	Means publishing notice in a legal newspaper because an interested individual's address or whereabouts are unknown. The fee (\$110.95) is paid when the petition is filed.

INTERESTED PERSONS ARE THOSE LISTED ON THE “PETITION” IN #2, #12, & #15, WHO PREPARED THE “REPORT TO ACCOMPANY” (IF DIFFERENT FROM ANY PERSON ON THE PETITION); AND THE PSYCHOLOGIST (IF YOU SUBMITTED AN EVALUATION).

In general, interested persons must be served:

- At least 14 days prior to the hearing if served by mail or publication.
- At least 7 days prior to the hearing if served by personal service.

### ATTORNEY GENERAL

If there are no presumptive heirs, the Attorney General should have been listed on the Petition in item #2 and must be emailed a copy of the Petition and Notice of Hearing at [AG-PA@michigan.gov](mailto:AG-PA@michigan.gov) or mailed a copy of the Petition and Notice of Hearing at:

**PROOF OF SERVICE** You, the Petitioner, must file a *Proof of Service* form with the court at least one week before the hearing. You may fax to 248-452-2016 or bring to the counter. If you fail to provide the Proof of Service, your Petition will be dismissed or adjourned.

---

**WAIVER & CONSENT** If a Proof of Service is not submitted, your Petition will be dismissed unless the interested persons have either been served or have signed a "Waiver and Consent", Form PC 561.

---

**HEARING DATE** The Notice of Hearing form displays the date, time, and assigned Judge. **The hearings are being held by Zoom unless the Notice of Hearing states otherwise.** You, the Petitioner, must attend the hearing or your Petition will be dismissed. The alleged individual with a developmental disability must appear at the hearing unless an "Affidavit and Order Excusing Respondent's Presence" (form PEMH 1100) that is signed by a physician or psychologist, is notarized, and filed by the attorney with the court.

**If you submitted a Psychological Evaluation, then that PSYCHOLOGIST MUST TESTIFY AT THE HEARING.**

---

**AFTER THE HEARING** If you are granted guardianship, you and any other co-guardians must sign an Acceptance of Appointment (Form PC 571) and put each guardian's date of birth on Form MC 97a. You may mail the forms in, bring them in-person to the counter, or fax to 248-452-2016.

---

**LETTERS OF GUARDIANSHIP** The fee to obtain a certified copy of the Letters of Guardianship along with the Order Appointing Guardian is \$14.00 each. Payment (cash, check, credit card) may be brought in-person to the counter or checks may be mailed in with the Acceptance of Appointment and MC 97a forms.

#### **ADDITIONAL FEES THAT MAY APPLY**

**ACCOUNTS** – (If you are appointed Guardian of the Estate) - **\$20 per annual account**

**PETITION FOR REINSTATEMENT** - (If you fail to file required documents timely and are suspended) - **\$20**

**COPY FEES** (if you request regular copies of documents) **\$1 per page**

**ADDITIONAL CERTIFIED COPIES OF LETTERS OF GUARDIANSHIP** - **\$14**

- **Miscellaneous motions and petitions**
  - **Annual Reports**
-
