Electronic Monitoring - GPS Rules and Regulations

- 1. Defendants are required to report to the telephone monitoring system as directed by calling at 866.507.7225.
- 2. Defendants can contact their assigned case manager Monday through Friday from 8:30 a.m. 4:30 p.m.
- Defendants will comply with all instructions from the PTS and/or monitoring agency.
 Defendants will return all calls from the PTS and/or monitoring agency immediately.
 Defendants agree that they may be required to report for equipment checks if
 necessary.
- 4. Defendants understand that all movement will be tracked and retained as an official record.
- 5. Defendants agree to carry or have their equipment on their persons at all times. Defendants will not deliberately conceal or cover the device in any way.
- 6. Defendants are required to charge their unit and/or change the battery as directed. When a defendant receives a low battery alarm, they are to charge the unit or change the battery as instructed. It is a violation to let the battery shutdown.
- Defendants are not allowed to go swimming, take a bath or submerge any part of the tether equipment in water. Defendants are allowed to take a shower and are required to dry the unit thoroughly.
- 8. If permitted by the court, defendants who need to change their residence or address must provide a minimum of 24 hours notice to PTS.
- Defendants leave schedules will be arranged pursuant to court orders and will be subject to charging restrictions. Defendants may be required to adhere to a daily "inhome" period for equipment charging.
- 10. Defendants may be required to provide verification of employment or any other matter that requires them to be out of the home.

- 11. All scheduled time changes must be done at least 24 hours in advance through PTS. When any violation of a schedule occurs, defendants must contact the PTS and monitoring agency.
- 12. Defendants agree they will not enter any area of restriction as instructed by PTS.
- 13. In the event of a medical emergency, defendants are permitted to seek medical attention at the nearest hospital emergency room. Verification will be required the following business day.
- 14. Defendants may be requested to allow inspections of the equipment by PTS, the monitoring agency and/or any other appropriate agency at any time.
- 15. Defendants will follow the payment schedule that is required by the tether company/monitoring agency.
- 16. Upon receiving a court order to remove a tether condition, defendants must contact PTS to arrange an appointment to have their tether removed. All issued equipment must be returned to the monitoring agency. Failure to return the equipment will lead to additional charges and/or possible prosecution.

Defendants who fail to comply with the above rules may be subject to a warrant being issued for their arrest or a hearing to revoke bond. Those who are violated in a court of law may have their bond forfeited and/or a higher bond issued.
