5. Freedom Hill.

Nancy Kolinski gave the Board an update on the Freedom Hill projects. She advised that the first round of invasive species treatment was done in the beginning of May. The treatment started as a spot treatment and is now a broadcast treatment. Discussion ensued as to the future treatment of the invasive species and the oversight of the treatment.

6. <u>U.S. Army Corps. of Engineers Inspection Report</u>

7. <u>U.S. Army Corps. of Engineers Spill Response Work Plan Agreement</u>

George Nichols presented the Spill Response Work Plan Agreement to the Board for approval. Through efforts from both Oakland and Macomb counties, a Planning Assistance to States grant that requires a 50% District match of \$204,760 will be utilized to meet the spill response needs within the Drainage District. Jeff Bednar offered insight as to the proposed monitoring technologies that are available to deploy within the Drainage District to detect contaminants. Mr. Bednar noted that upon approval of the agreement, the work plan will then be finalized and is expected to be implemented within the next month. Once completed, a 2-year pilot study is anticipated. Motion by Miller, supported by Vaara, to approve to enter into an agreement with the Department of the Army for the development of a comprehensive plan to improve spill response procedures within the Drainage District, allocate \$204,760 for the in-kind match contribution, and authorize the Chairman to sign the agreement on behalf of the Drainage District as presented.

On November 22, 2022, Wariz Group, LLC filed a Complaint in the Macomb County Circuit Court to Quiet Title to real property commonly known as 7001 Chicago Road, Warren, Michigan. The Complaint sought to determine the legal owner to a certain area of the property. The Red Run Intercounty Drain Drainage District was named as a defendant because it is a party with interest in the property.

In prior communications with the Wariz Group and its predecessors, questions of title arose regarding a parking lot located on and abutting the property. The parking lot is partially encroaching on an easement held by the District. The District acquired this easement in 1955 to construct and maintain the Red Run Drain, as well as to provide ingress and egress. The Wariz Group sought to acquire legal title to the parking lot from the District. While the District has an easement, it does not own the parking lot.

The law firm of Aloia Law represented the District in these proceedings. After the firm filed a response to the Complaint, the terms of a Default Judgment were negotiated with opposing counsel. On April 25, 2023, those terms were approved by the Court. A copy of the Default Judgment is attached.

The terms of the Default Judgment protect the District's easement rights now and into the future. On June 5, 2023, a copy of the Default Judgment was recorded with the Macomb County Register of Deeds. The question regarding title to the property is now resolved and the legal proceedings in the Macomb County Circuit Court have been concluded.

This matter having come before the Court on Plaintiff's Motion for Entry of Default Judgment and with the consent of Defendant Red Run Intercounty Drain Drainage District ("Red Run") acting through the Red Run Intercounty Drain Drainage Board; Defendant Estate of Minnie Kettle having been properly served by publication in accordance with the Order of this Court;

further, Defendant Estate of Minnie Kettle having failed to answer or take any legal action; and the Court being otherwise fully advised in the premises;

IT IS HEREBY ORDERED that the below described Subject Property located in the City of Warren, County of Macomb, Michigan is quieted in favor of Plaintiff, Wariz Group, LLC, a Michigan limited liability company, as its legal and equitable owner:

A parcel of land in Section 4, Town 1 North, Range 12 East, Lying Northerly of and between the Westerly line and the Easterly line of the following described parcel as extended to the centerline of Red Run Drain, the same being the Southerly line of Denton Industrial Subdivision as Recorded in Liber 78 of Plats, Pages 24, 25 and 26 of Macomb County Records: Beginning at a point on the centerline of Chicago Road, 66 feet wide distant South 82 Degrees 51 Minutes 30 Seconds East 829.0 Feet from the intersection of centerline of Chicago Road, and East right of way line of New York Central Railroad right of way being 50 feet wide; thence South 82 Degrees 51 Minutes 30 Seconds East, 457.54 feet; thence North 27 Degrees 27 Minutes 00 Seconds East, 269.76 feet; thence North 75 Degrees 40 Minutes 30 Seconds West, 42.78 feet; thence North 64 Degrees 45 Minutes 35 Seconds West, 589.49 feet; thence South 00 Degrees 28 Minutes 30 seconds West, 444.47 feet to the point of beginning, except that part deeded for road in Liber 2198, Page 264, Macomb County Records. (the "Subject Property")

above shall in no way affect, and be subject to, the easement rights of Red Run in the Subject Property as created in the Easement Deed from Minnie Kettle to the United States of America, recorded on April 17, 1952, in Liber 860, Page 422, Macomb County Records, and as conveyed to Red Run in the Quit Claim Deed from the United States of America as recorded on July 26, 1955, in Book 1008, Page 262, Macomb County Records and on August 26, 1955, in Liber 3393, Page 9, Oakland County Records ("Easement"). Plaintiff shall not construct any new improvements, or reconstruct, change or modify any existing improvements located within the Easement without prior written approval from Red Run, which Red Run decision on approval shall not be unreasonably withheld. Any improvements and all related appurtenances currently existing or permitted by Red Run in the future shall be subject to the rights of Red Run pursuant to its

Easement. Plaintiff shall not change the grade or interfere with or impede the flow of surface drainage within the Easement. If it becomes necessary for Red Run, its agents or assigns to maintain, operate, repair, clean, enlarge, relocate, or otherwise improve the Red Run drainage system, and in doing so it requires the removal, disassembly, disturbance or destruction of any improvements located within the Easement, Plaintiff shall be solely responsible for any increased costs to Red Run in exercising its rights under the Easement and all costs associated with the repair, restoration or reconstruction of any improvements. Plaintiff shall indemnify Red Run against, and shall forever hold Red Run harmless from, any and all losses, liability, actions, claims, demands, costs, expenses, personal injuries or property damages of any kind whatsoever caused by or arising out of Plaintiff's use of or acts within the Easement by Plaintiff, its employees, contractors, agents, representatives, guests, visitors, invitees, licensees, or any other person coming upon the Easement. The terms, conditions, covenants and other provisions contained in this Default Judgment shall run with the land and be binding upon and inure to the benefit of each of the parties hereto and their respective agents, successors and assigns.

IT IS FURTHER ORDERED that a certified copy of this Default Judgment shall be recorded with the Macomb County Register of Deeds and shall act in place of a deed and with the same effect as if a deed were signed and executed.
