- b. ArcGIS Software Updates (Susan Moore)
 - i. QA project is underway for Enterprise Upgrade.
 - i. Migrating to ArcGIS Enterprise 11.1
 - ii. Oakland County Desktops will be migrated to ArcMap 10.8.2 and ArcGIS Pro 3.1.
 - iii. CVTs/RCOC will need to migrate to services, rather than direct database connections.
- c. ArcGIS Enterprise Project Updates (Susan Moore)
 - i. Parcel Fabric Migration
 - Training for editors has begun. Go live is tentatively scheduled before the end of the year.
 - ii. Imagery
 - New imagery was acquired this past spring, 3" orthos (4-band) and 3" obliques. Imagery will be available in fall of 2023. There will be a new application replacing CONNECTExplorer. The BSA integration will change as well. More details will be available in late summer/early fall.
- d. Collaborative Asset Management System (CAMS) Program (Dennis Faustich)
 - i. The CAMS upgrade is complete for Facilities Management, Road Commission and CVTs. They were upgraded to Cityworks v15.7.6/ArcGIS 10.9.1 in the AWS cloud. WRC will remain on v2014 until their non-spatial asset workflows are redesigned for the newer versions of Cityworks.
 - ii. The RCOC Traffic Signal Management project has officially been re-kicked off. Currently meeting with Field Staff to design Inspection workflows in Cityworks to migrate staff away from using paper copies in the field and start using iPads.
- e. ArcGIS training and GIS training classes for CVTs and county staff (Bryan Debus)
