 - 31505 Grand River, Farmington D&A Development Partners presentation showing plans for this property including similar projects in New York City, NY and Birmingham, AL. Anne Jameson attended as consultant to concur with support of this project. A partnership with the OCLBA will really help the financial aspect of this project work. Kevin Christenson, Planning Building Director from City of Farmington also attended and spoke to Corridor Improvement Authority and desire for redevelopment in Farmington. This project is inside CIA and it's Master Plan. Hopeful for support for a project like this to breathe new life into it. He believes this building needs reinvestment before we lose it. He believes D&A are the first developer to take on the challenges and opportunities for this site. Discussion on land banking agreement having set timeline for activity to occur and protections for both former owner and OCLBA.
