- 3. A \$100.00 motion fee will be required with the filing of this motion.
- 4. You must state the specific circumstances that have changed since the last parenting time order that require a change in your order. You may include an additional sheet if you need more room to state your reasons. MCR 2.119 (A)(1)(c).
- 5. You must state the parenting time arrangement you are requesting. You may attach an additional sheet if you need more room. MCR 2.119 (A)(1)(c).
- 6. Please review your completed motion to make sure that you have provided all requested information.
- 7. Upon completion, use the MiFile system to electronically file this motion. **DO NOT FILE**
