Bids were received for the Randolph Street Drain Serenity Point and Riverbank Stabilization Project. VIL Construction was the low bidder with an amount of \$730,995. VIL Construction has worked on other portions of the Randolph Street Drain and has performed similar projects for the Oakland County Water Resources Commissioner's Office.

The project is estimated to cost \$972,862, and is expected to receive grant funds capped at \$560,000. Accordingly, the Drainage District is responsible for the remaining amount and both the City of Novi and the City of Northville are aware of the expected project cost.

Recommended Action:

- 1. Award the contract to VIL Construction, contingent upon the EPA grant being finalized and staff review of all documentation, bonds, and insurance, for the as-bid amount of \$730,995.
- 2. Authorize Jim Nash to sign the grant agreement upon receipt from EPA.
- 3. Authorize a project budget of \$979,862 for the Randolph Street Drain Serenity Point and Riverbank Stabilization Project.

Bid Results & Recommendation of Award

Dear Mr. Walsh:

Enclosed is the Bid Tabulation for the subject project. Four (4) bids were received and publicly opened and read at 3:00 PM on Thursday, August 29, 2024. The bid amounts ranged from a low of \$730,995.00 to a high of \$1,446,408.00. As shown, we find V.I.L. Construction, Inc., located in Sterling Heights, Michigan, is the lowest responsive bidder at a total construction cost bid of \$730,995.00.

V.I.L. Construction, Inc. has satisfied the bid requirements and has submitted all the necessary information in order for the bid proposal to be considered complete and responsive. They have experience working with the WRC and HRC, most recently with HRC on the City of Birmingham Municipal Parking Lot #5 Slope Restoration Project. The low bid was below the final pre-bid Engineer's Estimate of construction costs on this Contract.

Our office has contacted V.I.L. Construction, Inc. and they have indicated they are able to complete the project in accordance with the bid documents, schedule and for the amount bid. As a result, we recommend awarding the Randolph Drain – Serenity Point Project construction contract to V.I.L. Construction, Inc. for a total amount of \$730,995.00, subject to receipt of the appropriate bonds, insurances and executed contract. Construction is anticipated to begin January 2025 and be completed by June 30, 2025.

WRC staff have identified Phragmites on the Randolph Street Inter-County Drain within the Lexington Condominiums Complex (8 Mile Road and Taft Road) and is recommending this site be included in the 2024-2026 treatment program. The location of the treatment area is in the map below. Treatment will be completed by PLM Lake and Land Management Corp with a 3-year treatment not to exceed \$2,000.



Requested Action:

Approve PLM Lake and Land Management Corp to complete invasive species treatment on behalf of the drainage district for the next 3-years at a cost not to exceed \$2,000
