Welcome and Introductions

Chad and Amanda welcomed group. Member introductions were made.

Workgroup Updates

Amanda shared out two workgroup updates:

- DEIJ Workgroup: Amanda is reconnecting with community members who were interviewed for the Key Informant Interviews to confirm the community member summary accurately captured their collective responses. She is also asking how the council can do a better job connecting with community members.
- DUFB: The contract with Fair Food Network is done. Jessica Lofton-Williams shared FFN

Policy Updates

- Federal Updates:
 - Farm Bill: Both the Senate and House Agriculture Chairs, Sen. Stabenow and Rep.





GT Thompson, released their respective Farm Bill proposals in May. Read the bill summaries below along with responses to the proposed bills. One of the major differences between the two bills centers on SNAP re-evaluations that were passed in the last Farm Bill. These re-evaluations allow for SNAP benefits under the Thrifty Food Plan to be updated to align with the current Dietary Guidelines and to match the costs of purchasing and preparing food. Without these regular re-evaluations, benefits would be cut for recipients over time since it would keep pace with costs and preparation trends. Amanda will email Farm Bill workgroup to re-engage for the Council's education strategy.

- House Farm Bill proposal & Center on Budget and Policy Priorities response
- Senate proposal & FRAC response
- State of Michigan Updates
 - Summer EBT: Benefits will be available for the first time this summer, but the time
 frame for benefit release is TBD. Eligibility is based on spring count day. MDE is
 still processing applications for SFSP. There are 17 Oakland County school districts
 participating in SFSP. Once the list is finalized, Lori will share out. OLHSA will be
 having Meet up and Eat up in Pontiac, still working on site applications.
 - Hunger Free Campus program has been included in the House MiLEAP budget as a pilot program with a \$500,000 appropriation. The funding will go to a small number of schools as a test run, if it is unable to pass the policy portion of the legislation. The pilot program would support their efforts in instituting the full program for next year.
