Welcome and Introductions

Chad welcomed the group at large. Introductions were made in small breakout rooms to facilitate council members knowing each other better. After breakouts, members shared overall they appreciated the new arrangement.

Food Landscape Study Update

Guest Peter Lindeman (Public Sector Consultants). Peter provided an update on Oakland County's Food Landscape Assessment. Slides are attached. These are preliminary results from data collection, and a more detailed report will be made available at the end of the calendar year, along with another presentation by Peter. Workgroup updates:

Farm Bill Workgroup:

Lauren provided an update on the Farm Bill legislation. The proposed House Bill would eliminate Thrifty Food Plan (TFP) annual adjustments (included in 2018 Farm Bill), which accounts for more than inflation but also modern food shopping, preparation, practices and aligning with USDA Dietary Guidelines. SNAP advocates estimate that removing this allowance would reduce SNAP benefits amounts over time.

House Agriculture Committee Ranking Member David Scott (D-GA) recently wrote to his Democratic colleagues stating that the four House and Senate Agriculture Committee leaders (House Chairman Thompson, R-PA, Senate Chairwoman Stabenow, D-MI, Ranking Member Boozman, R-AR, and Scott) are in agreement opposing an extension of the 2018 Farm Bill at this point in time. Speaker Johnson's proposed CR had a one-year extension for the 2018 bill. The letter continues that the "four corners" agree that the best path forward would be a fiveyear, bipartisan, bicameral bill that would be included in a "must-pass" bill during the lame duck session.

In the House, Republican leaders are pulling together a continuing resolution that would fund the government for six months. It also includes controversial legislation opposed by most Democrats related to prohibiting non-citizens from voting. Currently non-citizens are not able to vote in the U.S., but the legislation would require potential voters to bring a proof of citizenship documentation to register to vote in a state. The House continuing resolution would also include a one-year extension of current Farm Bill programs which Congress has failed thus far to reauthorize.

In a coalition-based effort led by FRAC and several leading food policy stakeholder groups, nearly 1,100 national, state, and community-based organizations signed a letter to Farm Bill leaders stating that, although the letter-signers collectively believe that the 118th Congress can complete a new Farm Bill this year, that it cannot come at the expense of policies that address hunger, public health, farmers, workers, and the environment. Sustainable Agriculture also delivered sign-on letter. <u>You can view the formatted letter sent here</u>. They created a tool kit to use or share.

OCFPC Farm Bill Workgroup has prepared an educational 1-page document detailing SNAP and how it impacts Oakland County residents and businesses. Workgroup members are meeting again to prepare a communication plan and will share with members.

- Workforce development, job opportunities, and housing were top priorities.
- They saw priority alignment between their organizations and OCFPC.







Key findings from residents:

- Food security and access, along with cost of living, affordable housing, and transportation were key priorities.
- They expressed a split regarding alignment between community priorities and the councils.

Eric asked what the workgroup was doing to bridge the gap between the two perspectives. Amanda and Lori will bring the question back to the group during their bi-weekly meetings.

The workgroup will be developing an action plan regarding community engagement. Amanda asked group members how they preferred to learn. Top responses were in-person and webinar format. Amanda will bring this back to the DEIJ Workgroup.
