Does this plan provide Minimum Essential Coverage? Yes.

Minimum Essential Coverage generally includes plans, health insurance available through the Marketplace or other individual market policies, Medicare, Medicaid, CHIP, TRICARE, and certain other coverage. If you are eligible for certain types of Minimum Essential Coverage, you may not be eligible for the premium tax credit.

Does this plan meet Minimum Value Standards? Yes.

If your <u>plan</u> doesn't meet the <u>Minimum Value Standards</u>, you may be eligible for a <u>premium tax credit</u> to help you pay for a <u>plan</u> through the <u>Marketplace</u>. If you are also covered by an account-type plan such as the health savings account (HSA), then you will have access to additional funds to help cover certain <u>out-of-pocket expenses</u> - like the <u>deductible</u>, <u>copayments</u>, or <u>coinsurance</u>, or <u>benefits otherwise not covered</u>. In 2025, the County will contribute \$1,000/single or \$2,000/family to your HSA (if eligible), which will be 50% front-loaded with the first paycheck of the year.
