**Gartner Research Recommendation:** Research Conducted

Key Findings

- Microsoft Office 365 Groups and Teams have turned from exclusive, optional services into core services as they are integral to the overall Microsoft Office 365 ecosystem and the future roadmap of the service.
- Office 365 services will continue to diverge from their on-premises counterparts, if such counterparts exist at all.
- Customization capabilities will always be limited in the online version, in comparison with the on-premises version.
- Office 365's mature functions will change slowly (if at all), but new services, features and updates are introduced frequently.

Recommendations

- Application leaders evaluating or implementing Office 365 should:
- Ensure IT teams adapt their internal IT processes to cope with the frequency of Office 365 updates.
- Prioritize evaluation of the impact of Microsoft Teams on the business and its staff, and create a governance model and adoption strategy around this service.
- Dedicate staff to manage the aggressive change management schedule and monitor the new services, roadmap and messaging from Microsoft.
