The State is requesting information so they can determine timing for the implementation of their mandated Statewide e-Filing system (MiFILE) for the 52nd District Courts. In order to determine when IT can have this done they need to size it. See below for the Request.

The Courts Justice Leadership Group (on behalf of the four 52 District Courts) is requesting an eVote approval to size a project to support the implementation of the Statewide e-Filing system, sponsored by the State Court Administrative Office (SCAO), for the 52nd District Courts. The hours to complete the sizing will come from Courts Sizing Budget which currently has 300 hours. This sizing project is estimated at 20 hours.
