DATE: July 21, 2022

The Sir Drain was inspected in 2015 and the inspection yielded approximately \$600 worth of repairs. The repairs primarily consisted of downed tree removals. The drain was inspected again in 2018 and yielded approximately \$400 worth of repairs that consisted of removing downed trees. An inspection is scheduled for 2022 and is estimated to cost \$1,100.

There have been no operational complaints since 2015.

The maintenance account has a deficit balance of (\$1,475) as of March 31, 2022. The assessment length of the drain is two miles. The drain is apportioned to Oakland County 86% and to Genesee County 14%.

### **Requested Actions:**

Authorize the Oakland County Water Resources Commissioner to perform the inspection and necessary maintenance (as limited by the Michigan Drain Code) for 2023.

Approve an assessment of \$5,000 for 2023.
