Marketing Summary 01/25/2022 to 01/25/2023

OMIDD January Insurance Renewals Summary

We have completed the marketing process for the OMIDD insurance program renewing January 25, 2022. The hardening marketplace continues to be a major challenge through most lines of coverage, with carriers reducing capacity, increasing rates and in some cases, withdrawing from certain segments of the market altogether. For the OMIDD January insurance renewals, we approached the Public Entity marketplace seeking the most competitive terms for the 2022 renewal to replace the collapsed Liability program through Trident. Our objective is always to provide the broadest coverage at the most competitive pricing.

From the table below, the <u>total</u> renewal premium for the January insurance policies increased from \$764,652 at expiring to \$843,680 (+10.3%) at renewal. Some notable points regarding the marketing of the 2022 OMIDD insurance renewals are:

• Property Coverage: The expiring Chubb property policy was written on a (2) year term and this is the end of the two year policy. We marketed the property policy however based on appetite, coverage, and price Chubb was still the best carrier to place the coverage. We negotiated the renewal for the multi-year term to a below average rate increase at 5%. Property insurance is seeing low to mid double-digit rate increases due to increased claims payouts and industry profitability related to weather incidents and national disasters. The renewal premium has increased 10.2% for this renewal, which includes the 5.2% Engineering News Record Construction Cost Index value increase, and a 5% property rate increase putting the total annual premium at \$381,961. They are offering a 5% increase for the 2nd year of the term, we suggest this approach due the market trends over the last couple years to lock in the below average rate increase. If anything changes in the property market we will revisit alternatives.



Marketing Summary (continued)

- Public Entity (PE) Liability: Due to reinsurance issues, unfortunately the Trident Program is no longer offering public entity liability coverage. Disappointing as this was a great program. As a result, we approached the marketplace for any carrier that can consider drainage districts. Based on our efforts we recommend replacing Argonaut with Lexington (AIG). OMIDD had been placed with AIG previously which historically was a good relationship before moving to the Trident Program. The size and scope of OMIDD is too large for what most carriers are willing to consider in their appetite for a drainage district. The public entity marketplace is seeing considerable disruption in rate, coverage, and capacity for limits. This has sparked a deeper dive seeking new options since mid-2021 upon news of Tridents pullback and currently Lexington is the best alternative for OMIDD and similar risks. Lexington's original premium came in at \$249,205, but Meadowbrook was successful in negotiating a \$5,945 reduction in premium from Lexington's original quote; Bringing the renewal premium for PE Liability to \$243,260.
- Excess Liability: The excess marketplace is continuing to be impacted by the hard market more than any other line of business. A majority of the carriers have continued cutting back on limits and raised their minimum premiums. We were happy that AWAC was willing to stay on the full \$10M excess of primary policy without needing to find other carriers to take that capacity. Merchants National Ins. Co. will be filling out the \$10M excess \$10M policy to complete the liability tower. Excess policies follow the pricing of the underlying policies, therefore, our excess renewals have increased at roughly the same rate as the primary policy with AIG.
- <u>Pollution Liability:</u> Zurich pulled out of the site pollution marketplace sparking the non-renewal of the pollution coverage on OMIDD. We sought replacement options with several carriers and ultimately Chubb provide the best coverage available. Their initial quote was \$67,962, however we were able to negotiate that down to \$63,457. We had an alternative option from Ironshore at \$63,062 however after reviewing policy forms we are recommending the slightly higher option from Chubb which is still a -4.4% decrease over expiring coverage with Zurich.

NTH is currently overseeing the design of the North Interceptor-East Arm (NI-EA) Contract No. 2 PCI-18 and PCI-18 Rehabilitation (NI-EA C2) Project and the construction of the OMID Control Structure 9 (CS-9) Gate Installation. Recent developments on both projects have created a need to obtain air quality and pressure readings within project zones.

As the design phase of the NI-EA C2 Project approached 100%, the OMID Project Team discussed the need to evaluate hydrogen sulfide and air pressure within the project zones in order to determine ventilation requirements for construction. Specifically, these locations are in proximity to the proposed 7 Mile Adit Structure and existing PC-663 at 7 Mile and Van Dyke and the proposed lining at the Conant/Meldrum connections into the NI-EA in proximity to Meldrum and Gratiot. In addition, as the Board is aware, recent damage has occurred to the OMID PCI-5 HOBAS liner within the Oakland-Macomb Interceptor Drain as a result of two CS-9 roof hatches falling into the sewer after being lifted from their seating due to internal positive air pressure fluctuations. The OMID Project Team would like to understand these pressure fluctuations through sampling and eventually accommodate for them either with modifications to CS-9 and/or the overall design of the OMID Odor/Corrosion facilities (in which proposals were received on January 14, 2022).

Previously, Jacobs has facilitated hydrogen sulfide and air pressure sampling for the following OMIDDD projects:

- NESPS Odor/Corrosion Project
- OMID Odor/Control Study
- NI-EA Phase 1 Sampling (within failing PCI-4 Milliken Geo-Spray section)

Due to Jacobs's familiarity with the OMID and NI-EA systems and previous sampling work, as well as the urgency to obtain this data as to complete the NI-EA C2 Design for bid in March-April 2022, we believed it to be prudent that they complete the required sampling.

As NTH is the lead designer and contract administrator for both projects, we have asked them to retain Jacobs under their contract to provide oversight and support as required. Accordingly, NTH has prepared the appended January 10, 2022 proposal for these sampling services consisting of the following tasks:

Task 1: Project Kickoff and Data Acquisition Plan

 Hold a meeting to discuss overall goals, background, schedule and data acquisition approach, then finalize sampling plan.

Task 2: Data Acquisition

• Deploy eight (8) Acrulog Hydrogen Sulfide loggers and eight (8) sewer differential pressure loggers at 8 locations within the project zones for a four-week total duration. Traffic control will be provided by NTH.

Task 3: Estimation of Air Flow Rates

• Estimate the air flow rate needed to provide a safe atmosphere for the contractors who will be working in the NI-EA according to industry standard safety levels.

Task 4: Meeting and Reporting

- Prepare a draft technical memorandum to summarize project findings and hold a meeting to discuss.
- Finalize the technical memorandum and distribute electronic and hardcopies to OMIDDD.

METCO has been providing flow control support and maintenance coordination for OMIDDD under multiple contracts since 2016. At the October 21, 2021 OMIDDD Board Meeting, the OMIDDD Board approved an Engineering Work Order (D-424) for a complete scope of services under Contract #5517 that included OMID flow control operations and control structure maintenance (including asset management through NEXGEN), NESPS maintenance, and project-based support through the end of 2023.

Since the approval of their change order a few scenarios and needs developed over the past year that required additional resources and effort to be expended by METCO personnel as follows (Note section numbers in parenthesis indicate applicable section of METCO's change order scope of services):

- (Section 3.1) Additional corrective maintenance, engineering, oversight and coordination during the loss of critical equipment and appurtenances including, but not limited to:
 - o NESPS Transformer 3
 - NESPS Transformer 4
 - NESPS Pump #2
 - NESPS Pump #5
- (Section 3.3) Additional flow control manager and engineering support for project integration.
- (Section 3.4) Additional flow control operations support, including lock-out, tag-out (LOTO) and monitoring for project-based activities which required weekday and Saturday overtime.
- (Section 6.0) Additional personnel effort for the development and management of the NEXGEN
 asset management system, including reporting needs. The program is utilized to schedule
 preventive and corrective maintenance, organize documents, perform risk analysis and
 condition assessments and prioritize/budget for capital and maintenance projects.

While we are in the process of upgrading the NESPS, we expect that continued corrective maintenance and engineering support will be necessary until the NESPS has been fully rehabilitated in 2023. In addition, construction projects, including the MIDDD Segment 5 Lining, NI-EA Contract No. 1 PCI-4 Rehabilitation are anticipated to continue well into 2022 and the NI-EA Contract No.2 PCI-17 and PCI-18 Rehabilitation Projects will extend into 2023. These projects will require flow control support services. Finally, for the NEXGEN software to be utilized, it is imperative that it be updated on a regular basis and reporting be made annually for GLWA and OMIDDD needs.

Accordingly, METCO provided the attached October 26, 2021 proposal for the additional costs they have already incurred for the above services as well as the anticipated costs expected for these services through the end of 2023. The total additional effort for these services is as follows:

3.3 Maintenance – Project Construction Coordination

Provide OMIDDD and NESPS Project support during construction projects as follows:

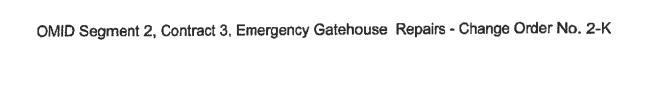

- Jacobs has submitted a proposal for additional data gathering (H2S and pressure readings) within the NIEA and OMID portions of the system to further evaluate impacts from flow control sequencing. Final Report will be updated to reflect new data, once gathered and evaluated.

coating within the discharge manifold piping in early 2021, abandoned further (relatively small) defective work repairs and began close-out and final settlement negotiations with Inland Waters. Closeout documentation for Contract 3 (including C.O.) prepared and in process for Board Approval.

deterioration noted in early 2021; also see NIEA Contract 1 Summary. A further manned inspection of PCI-4 adjacent to the NESPS gatehouse is planned for early 2022, pending access availability. Representatives of the Project Owner, the Contractor, the Engineer, and the lining manufacturer will participate in an effort to better understand the deteriorating condition of the current spray-on cementitious lining material. This initial section of PCI-4 currently planned for re-lining (using GFRPMP) under NIEA OMID Contract 1 (PCI-4 Rehabilitation).

Schedule Status: Ongoing

Status of Emergency Contingency Plan for pumping during total power loss or other catastrophic system failure:

- Mersino Dewatering is under contract for standby emergency bypass pumping.
- The OMIDDD Project Team is currently designing an approach for keeping the 15 Mile Road bypass pumping arrangement intact. Plans are now in place for demobilization of the pumping and support equipment, with the bypass piping remaining on site pending final decisions on a potential permanent installation.
- The OMIDDD Design Team has met initially to discuss modifications to the current DRAFT Emergency Plan, based on the lessons learned from the July 2021 partial implementation of the plan.
- Remaining items in the final emergency plan include punch-list and optimization steps for
 electrification, the modification of one manhole, modifications at the 15-Mile Road Site, and
 overall optimization of the Emergency Plan per above.

Additional work being performed under Metco Maintenance Contract for NESPS:

- Flow control operations related to OMID/MID/NIEA sewer repair and upgrade projects are ongoing.
- Mechanical and Electrical corrective/preventative maintenance schedules continue.
- Coordination between GLWA, MID, NESPS, and Pump/Electrical Upgrade Project has not affected station operations nor hindered performance or abilities to meet demands.
- Wet well sediment inspection and barscreen cleaning scheduled to take place January 21, 2022.
- The OMIDDD Project Team is researching methods for using high pressure water onsite for bar screen cleaning and has met with representatives of the NLB Corporation for a presentation on potential screen cleaning equipment. Further consideration of this technology is ongoing; several questions to be addressed by NLB.
- NESPS Health and Safety Plan finalized.

Overall Station Performance Report:

- Sanitary Pumps #4, #5, and #6 are ready for duty with no issues to report. Pump capacity as of January 6, 2022 is 350-cfs.
- Sanitary Pump #2 experienced a series of exciter/motor faults and alarms. As a
 precaution, the pump was removed from service December 2, 2021. MCE and IPS
 (Integrated Power Services) conducted a thorough inspection on the motor and
 exciter and found damage to several components related to the exciter mostly due to
 fatigue. Tests on the motor were good. (Report on file).
- Equipment Shutdown Request (ESR) on Sanitary #2 submitted to GLWA.
- IPS received and tested new exciter components January 4, 2022. Installation of new components is scheduled for January 7, 2022.
- Sanitary Pump #1 remains out of service as part of the upgrade project. The Pump #1

- knife gate valve has been removed under flow control. It is flanged off with no leaks.
- Existing Transformer 4 and Standby Generator remain for supply and back-up.
- New Transformer 3 has been energized and remains ready for connection.
- NEXGEN asset management in use.
- Gas detection faults/alarms have been investigated by contractor and reviewed by the OMID team in both dry and wet wells. Protocols related to alarming have been modified by OMIDDD.
- A revised parameter change for the HVAC system was put in place to correct inconsistencies within the program. OMIDDD has reviewed and accepted changes.
- Bio Filter performance normal with no odor complaints or issues to report. Parameters checked daily and shared with Bio Aire on a weekly basis.
- Overall General Housekeeping tasks in order. Minor maintenance activities addressed in a timely manner.

Control Structures Performance Report (CS-5, CS-6, CS-7, CS-8):

- Daily flow control operations now support MID/OMID/NIEA repair and improvement projects.
- All LOTO protocols are in-place with no major issues to report.
- System-wide communications are good.
- CS-6 in stand-by mode ready for service. MCPWO/MCE has completed modifications to communication protocols.
- CS-7 in stand-by mode ready for service.
- CS-8 in stand-by mode ready for service.
- CS-5 in stand-by mode ready for service.
- CS-9 developed actuator oil leaks on both gate #1 and #2. Repairs are complete. CS-9 gate
 cleaning and level sensor calibration certification completed and accepted by OMID. CS-9 leak
 test and Hobas lining inspection also completed. Hobas lining repair scheduled for upcoming
 spring. CS-9 is providing storage support for NIEA related repair tasks. Data from daily
 storage/release operations are being analyzed by ASI.
- Routine daily rounds and inspection made with no major maintenance issues to report at this time.

Other System Operation Issues

- O&M Manual currently being revised to include new structures, recently modified structures, new monitoring equipment, and recent inspection and repair status.
- EGLE has informally agreed to consent to use of all flow control structures for long term flow control. Request for formal consent is under review by them.

• Hatch and Access improvements complete, CSM Contract closed-out.

• CS-5, CS-6, CS-7, and CS-8 mechanical repairs have been completed by HESCO and control structures are in stand-by mode, ready for service.

• HESCO has provided a study of control structures that evaluates long-term operability. This document is currently under review, and design for upgrades is in planning stages.

OMID System 3-Year Spot Repairs and 6-Year Inspection Status:

Amt Invoiced: Total design and construction budget for 3-Year repairs currently is established

as \$1,352,801 (including contingencies and admin/legal).

Schedule and Progress Status:

 Remaining 3-year spot repair work consists of step removal at one manhole in PCI-8, delayed due to access issues and timing of other work.

- The 6-Year inspection began July 8, 2021 and is on hold pending flow control availability. Inspections remain to be completed in PCI-7 and PCI-8.
- Some damage noted to the CIPP Liner installed in 42" section of PCI-11A. Design Team is finalizing options for repair.

NIEA Repairs (Design/Construction)

Amt Invoiced: \$2,162,305 out of currently projected study/design budget of \$2,400,570; Total

design and construction budget currently is \$44,168,770 (including contingencies and admin/legal). The current value of work completed is \$6,418,486.75, which represents 41.7% of the Contract sum, based on the current application for

payment, and including stored materials.

Schedule Status: Contract 1: PCI-4 Interceptor Outer Drive Access Shaft excavation continues with

the internal rib system installation now complete. Access shaft excavation has exposed the PCI-4 Interceptor, and soil and groundwater conditions continue to be favorable. Work has also commenced on the installation of the structural steel portal bracing within the access shaft; no flow control measures are required for this activity. The project is currently behind schedule primarily due to flow control issues; however, the Contractor is varying the work sequencing schedule to improve

the current schedule delay impacts.

Contract 2: 100% design work complete; expected to bid in April 2022 pending permit resolution and coordination with GLWA projects that impact flow control

requirements.

Progress for both contracts is summarized:

- Flow control necessary to complete Contract 2 work is expected to impact a downstream GLWA project (DB-226). Contract 2 is being structured such that potential interference between the two contracts can be mitigated.
- Current City of Detroit permitting issues have also forced delay of the bid advertising date (now expected in April 2022).
- A protocol for inspection and monitoring to compliment the pilot study is drafted for internal and GLWA review. This protocol will be included in the 100% design package.
- Working with GLWA to develop cost sharing agreement; Draft agreement is currently being reviewed by GLWA Legal.

- Discharge piping work is underway on Pumps # 1 and # 3, including pressure testing.

- Chemical injection to seal groundwater infiltration at the existing discharge pipe wall
 penetrations is substantially complete, with final efforts on hold to observe the initial stages of
 grouting and determine if further measures may be required for final leak control.
- Small diameter conduit runs are being installed in the existing NESPS building with favorable progress.
