IT IS ORDERED:

The purpose of this order is to designate schools within the jurisdiction of the 52-1 District Court where sessions of the court may be held for specific cases.

1. **The 52-1 District Court is authorized to conduct court sessions at the following schools within their jurisdiction.**

 - e) Novi High School, 24062 Taft Rd., Novi, MI 48375
 - f) Walled Lake Western High, 600 Beck Rd., Commerce Twp. MI 48390
 - g) Milford High School, 2380 S. Milford Rd., Highland, MI 48357
 - h) Walled Lake Northern High School 6000 Bogie Lk. Rd., Commerce, MI 48382
 - i) Walled Lake Central High School 1600 W. Oakley Park Rd., Walled Lake, MI 48390
 - j) South Lyon High School 1000 N. Lafayette, South Lyon, MI 48178
2. **Litigants may decline to participate and may request that their cases be heard in the courthouse proper at another time.**
3. **These off-site sessions will be open to the public.**

4. The plan for these off-site sessions takes into account factors regarding:

- a) Security
- b) Approved recording of proceedings
- c) Notification to parties/witnesses/public
- d) Adequate sound systems
- e) Site decorum, furniture, and audience preparation
- f) Transportation of court files and records
- g) Post hearing transactions such as payments and clearances
- h) Home court coverage.
