## Michigan Trust Code

If you haven't already seen or heard about it, you will want to start looking into the new Michigan Trust Code. 2009 PA 46 amends EPIC and enacts the Trust Code that was approved by the governor on June 18, 2009. Conforming changes to other statutes for the purpose of consistency are contained in concurrently adopted legislation found at 2009 PA 42 to 45.

The effective date of all the relevant acts is April 1, 2010. You can access the full text at <u>www.legislature.mi.gov</u>. If there is a SCAO form for what you wish to file, please use the SCAO form and attach additional pages as necessary. If there is an Oakland County version of the SCAO form, we require the Oakland County form to be used.

This site also includes links to brochures on different types of probate proceedings and a great deal of other helpful information (including past *Laches* articles!)

The Oakland County Probate Court accepts documents for filing by fax if there is no fee required for the filing. The Probate Court fax filing line is (248) 452-2016. Proofs of Service and GAL reports may also be dropped off in the specially designated basket on the counter next to our cashier for same-day processing.

For motion call, it is especially helpful to have all documents, such as the Proof of Service, in the file prior to hearing date. This reduces the lines at the counter and helps move everyone through the process more quickly.
